WARNING AND ASSUMPTION OF PHYSICAL RISK AND WAIVER OF LIABILITY

By its nature, participation in interscholastic athletics includes a risk of injury which may range in severity from minor, to long-term catastrophic, to death. Participants can and have the responsibility to help reduce the chance of injury. Players understand and, by their participation, agree that they must and will obey all safety and training rules, follow directives of the coaches, promptly report all physical problems to their coach, follow a proper conditioning program, and inspect their own equipment daily. By signing the permission form, parents and students acknowledge that they have read and understood this warning. Parents or students who do not wish to accept the risk described in this warning should not sign this permission form.

CONSENT AND WAIVER OF LIABILITY OF PARENT(S) OR LEGAL GUARDIAN(S)

I hereby give my consent for the above named student to: (1) Engage in Yorkville Christian School and IHSA approved activities and to represent Yorkville Christian School in those activities (excluding those activities indicated by an examining physician), (2) accompany any school team of which they are a member, on any of its local or out of town trips, and (3) be given professional emergency first aid or medical care that may become reasonably necessary for the student in the course of such athletics participation.

I understand and acknowledge that the above student has received a pre-participation examination, and that this examination cannot completely assure that the student is completely physically able to participate in the above-named supervised activity.

Therefore, we, and our agents, representatives, assigns, heirs, and successors hereby waive, relinquish, and hold harmless, Yorkville Christian School, its individual Board directors, trustees, officers, administrators, employees, agents, representatives, coaches, volunteers, insurers, assigns, and successors, and each and every one of them, from and against any and all claims, demands, suits, liability, and causes of actions, whether known or unknown, past, present, or future, including, but not limited to, any and all costs, expenses, and attorneys' fees, by reason of our child's/children's injury, illness, allergic reaction, loss, or death, arising out of, in connection with, or in any manner related to their participation in the athletics program.

We have carefully read this Consent, Assumption of Risk, and Waiver of Liability and fully understand its contents. We are aware that by signing this document, we are waiving our rights and the right of our child or children, to the extent allowed by law, to sue Yorkville Christian School, the Board, its individual Board directors, trustees, officers, administrators, employees, agents, representatives, coaches, volunteers, insurers, assigns, and successors, and each and every one of them. This Waiver is complete and signed of our own free will. We are aware that this form is a contract between ourselves, our child/children, and Yorkville Christian School. We further certify that we have the legal authority to sign on behalf of ourselves, our child/children, and our family.
